**Who Should Attend:** All individuals who are planning on taking a water examination for the first time or individuals with D-I or T-I, upgrading their license must have attended this required course before sitting for D-II thru D-IV or T-II thru T-IV water certification examination. Also those wishing to refresh their mathematical skills.
